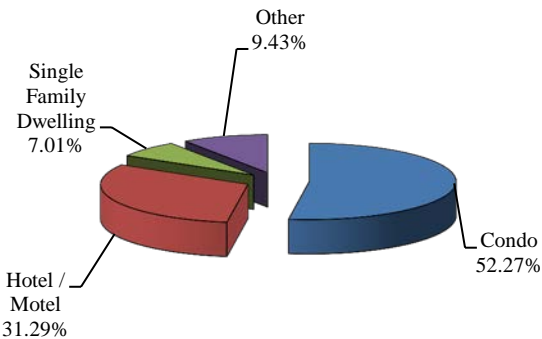

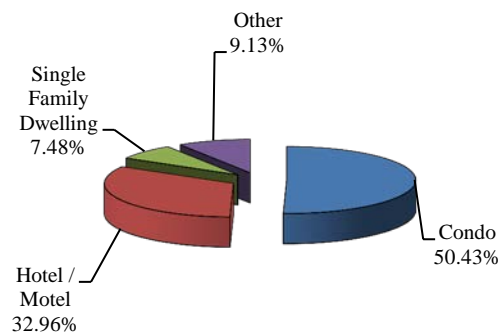

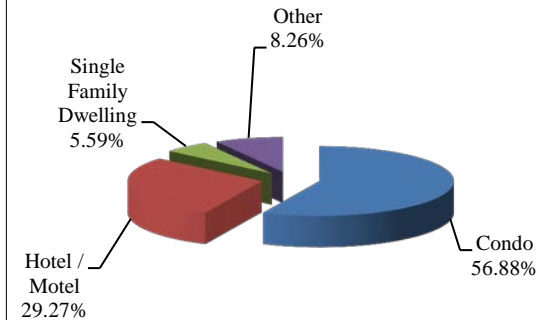
Gross Rental by Rental Type



Taxable Rental by Rental Type



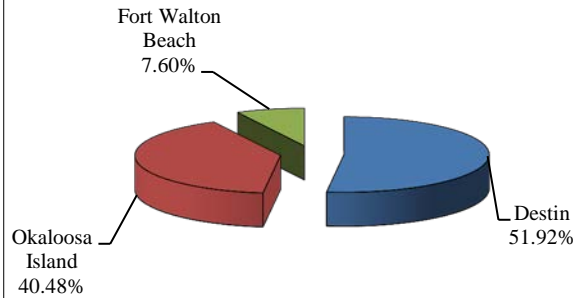
Number of Units by Rental Type



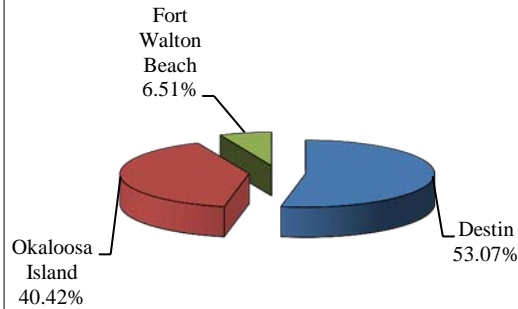

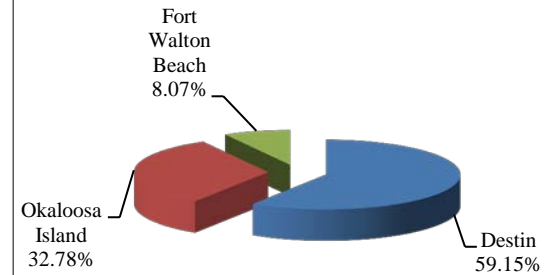
Gross Rental by Tax Area



Taxable Rental by Tax Area



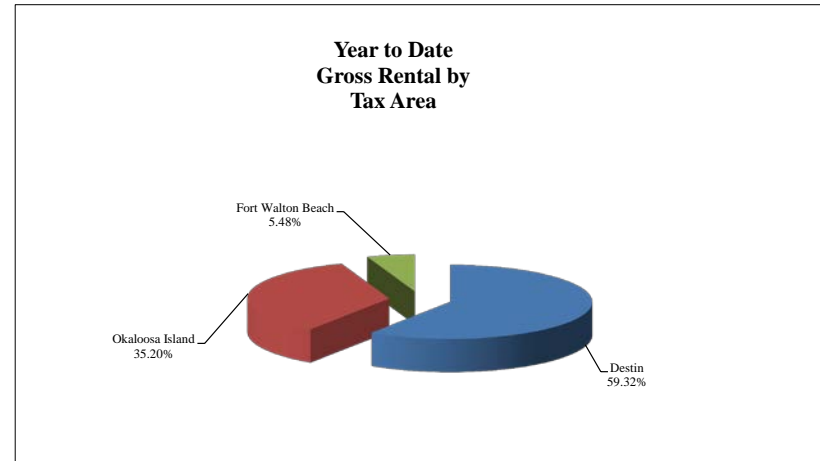
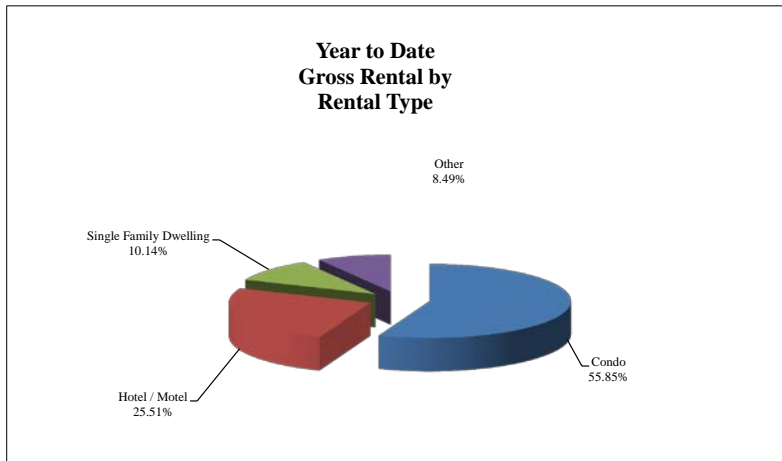
