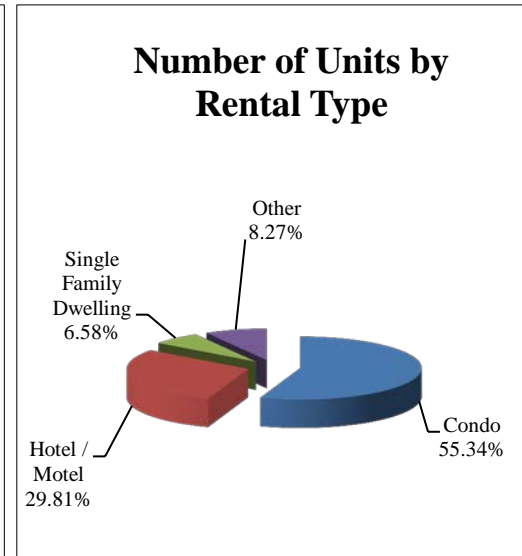

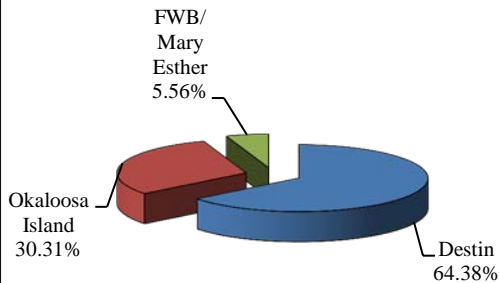


Percentage of Gross Rental, Taxable Rental, Number of Units, and RevPAR by Tax Area November 2016

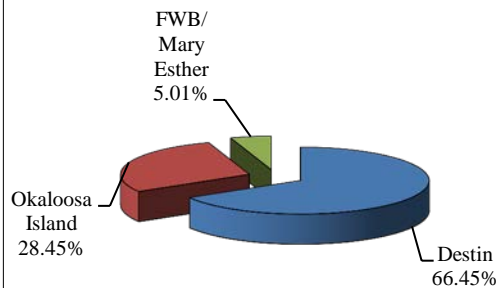

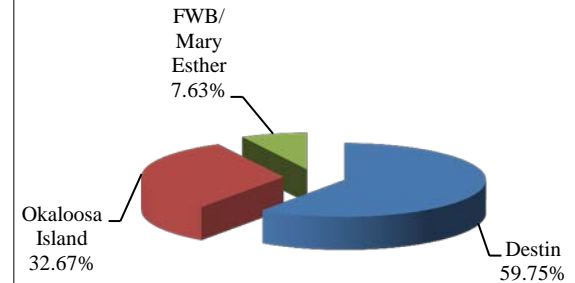
Gross Rental by Tax Area



Taxable Rental by Tax Area



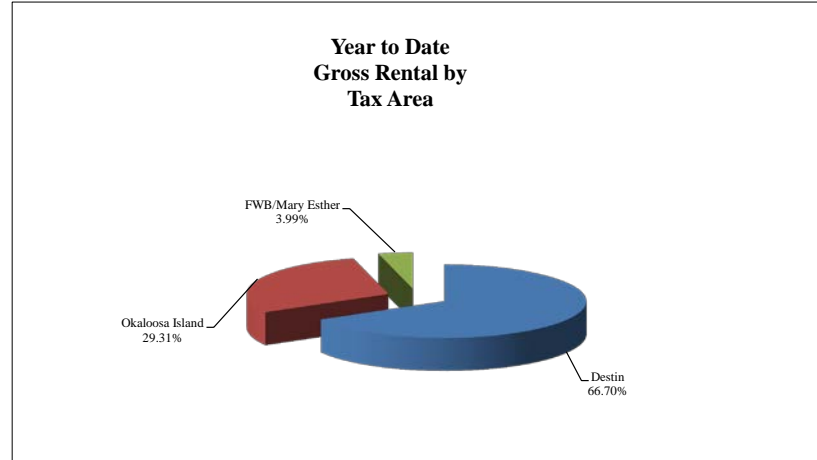
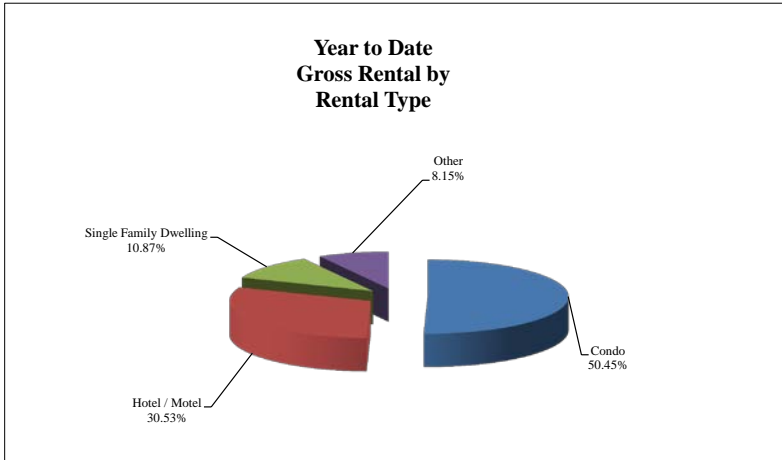
Number of Units by Tax Area

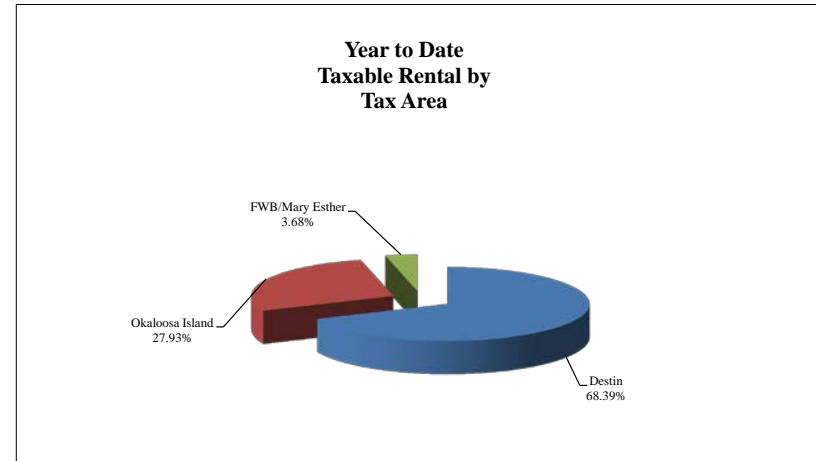
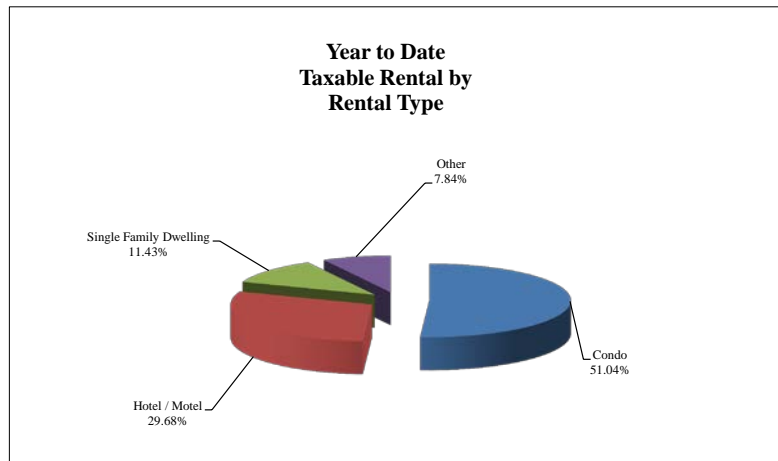
